ATTENTION EXHIBITORS

In accordance with American Kennel Club Tracking Regulations Chapter 5, Section, 1, Amended to January 2014, dogs entered in this test must have earned a TD or a TDU title. Entries without a VST title will be accepted first.

There will be no actual scores for the tracking test, but the dogs will be rated "Passed" or "Failed" and an appropriate certificate will be issued by the American Kennel Club confirming all dogs rated "Passed".

TELEGRAPH, telephone and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

ENTRY FEE for VST is \$125.00 (includes 50 cents Recording Fee) made payable to Lyons Township Dog Training Club, Inc. A Recording fee of 50 cents and event fee of \$3.00 will be required for each dog entered at any licensed or member club show, or obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. Entry fees will be refunded within seven (7) days after completion of the Test in the event all tracks have entries or alternates have replaced entries. No entry fee will be refunded if the request is made after closing date and all tracks are not used.

ENTRIES cannot be accepted, canceled, altered or substituted after the entries close with the test secretary.

THE Variable Surface Tracking Test is limited to 8 dogs. In accordance with the AKC Obedience Regulations (AKC Rule, Chapter 1, Section 26a) entries in this VST Test shall be accepted up until the official closing date, even though the advertised limit has been reached. A drawing will be held on Thursday, September 16, 2021 at the secretary's home at 6:00 pm to determine which entries will participate in the tests. This drawing shall be completely random among all entries received except that preference shall be given to dogs, which have not earned VST titles.
